Community Day - Friday 19th June 2015



USB thumb drives are a very convenient way of transferring data but did you know that transferring business data on them can be illegal? The Data

Protection Act states that "Appropriate technical and organisational measures shall be taken against unauthorised or unlawful processing of personal data and against accidental loss or destruction of, or damage to, personal data" meaning that using an unencrypted drive, which 98% of USB thumb drives sold each year are, to transfer customer data breaches this section of the Act.

USB storage devices also provide an easy way to transfer viruses and malware and dropping infected USB thumb drives near an organisation is a well-established method of attacking it. This was the method the US government used to damage the Iranian nuclear weapons programme!

However, one of the most worrying trends from 2014 was the discovery of "tainted" USB sticks; USB sticks which contain a miniature computer designed to attack any system they're plugged into. When triggered, these sticks impersonate the user (bypassing any antivirus programmes), and can steal data or perform criminal activity without the user being aware.

The most effective way or dealing with this threat is to disable all USB storage on your network and use a secure remote access or cloud based solution to access data (using free cloud services such as OneDrive or DropBox can also breach the Data Protection Act!). However, if you must use USB storage, encrypted drives are available for only slightly more than a standard USB drive.
