Aching Arms, Bringing comfort after pregnancy and baby loss

Eight years ago my partner and I were devastated when our baby, James, died when I was five months' pregnant. One year on, I was walking through the Woodman Road Cemetery on what should have been my first Mother's Day when it struck me that I needed to start living again and not allow grief to take away everything I felt I had to offer my community. So I decided I wanted to help and support the mental health and healing of other bereaved parents.

The result was Aching Arms, which I founded in June 2010 and which became a registered charity in August 2013. It is now a national organisation, recognised across the UK for our work in supporting bereaved families.

Aching Arms donates teddy bears for midwives to give to newly-bereaved mothers and fathers as a 'comforter', to hold as their arms ache to hold the baby who has died.

When I started Aching Arms, the aim was to get 10 comfort teddy bears into Queen's Hospital, Romford, and then just to see how it went from there. We now supply 80 hospitals with comfort bears – with more and more hospitals coming on board all the time – and we've given out a total of more than 4,000 bears.

We also reach out to anyone who contacts us via our website, email, Twitter and Facebook, and we post out

around 50 bears a month directly. I lead free 'awareness sessions' at hospitals across the country, in which I encourage health professionals to reflect on how they care for bereaved parents.

Aching Arms is run by a Board of Trustees and in October 2014, I became the part-time, paid Charity Co-ordinator. We have a team of 10 dedicated volunteers who post bears directly to bereaved families and a network of 65 enthusiastic volunteers across the UK who ensure we continue to offer comfort after pregnancy and baby loss by helping prepare bears to go to hospitals.

We're expanding rapidly, enabling us to offer comfort to more and more families, but partnerships with businesspeople such as those in the Chamber of Commerce are vital in helping us raise awareness and secure funding for our service.

### Meet the Members



Peter Clements

In our new feature we put one member under the spotlight and 'grill' them (light-heartedly) with some questions about both their business and their personal lives.

Our first subject is Chamber Vice Chairman and Treasurer Peter Clements, who is semi-retired, and who has blended sporting interests with a fulfilling career in the accountancy sector.

Q: May we have a potted history of your business life?

A: I qualified as a Chartered Accountant in 1970 and then joined Bairstow Eves (estate agents) as Personal Assistant to the senior partner - who was also a director of 40 other companies! The following year I became Bairstow Eves' first Company Secretary, continuing in that role till 1977. Bairstow Eves now has over 600 offices. I joined Maurice J Bushell & Co Chartered Accountants, a London practice established in 1876, then opened a Brentwood office for them and became a Partner in 1982. I ran the office till May 2010 when I sold the Brentwood practice to M.J. Bushell Ltd. Although

I'm technically retired, I'm still a partner in the London office and help MJ Bushell Ltd when required.

Q: What made you decide to

join the Chamber and how long have you been a member/on the Executive Committee?
A: I joined the Chamber over 25 years ago, because I thought it would be useful to meet up with other Brentwood businesses. I joined the Executive Committee in 2001 and

### Q: What about your hobbies/interests outside of work?

A: I have been involved with the Old Brentwoods ever since I left school in 1961, playing football and cricket for them for many years. I was President of the Society in 2000 and Secretary for many years to 1989. I was also President of the football club for seven years to 2001, Secretary for many years in the 1960s and 1970s and have been Treasurer since 1994. I joined the Rotary Club of Brentwood in 1990 and was their President in 2001. My other roles include being a Director of The Brentwood Town Centre

Partnership for five years to 2005 and Director/Treasurer of Brentwood Theatre for five years until 2007.

Q: Can you tell us something interesting about yourself that not many people know?

A: I had a trial for Leyton Orient Football Club in 1963 when they were in the old First Division and have been very keen on football all my life. (I also managed Brentwood Boys Football Club – my younger son's club – for four years and was their Treasurer for many years). And I've also run

several marathons, including the London Marathon!

Q: You're on an extra strict version of Desert Island Discs and you're told that you can take only one item to the island: what would you take?

A: If I can't take my wife – or my dog! - I'd take a photo of our extended family (between us we have six children and 13 grandchildren). I hope I'd also be allowed to take another photo, of my late father, who was killed in the Second World War, and who I never knew.

# Art for art's sake – gallery myths debunked

The secrets of running an art gallery were revealed at our July Business Breakfast.

The well-attended event was on 14 July, at Marygreen Manor.

We were delighted to welcome new Brentwood & Ongar MP Alex Burghart and to hear him speak (see below).

Appropriately, the discussion topic around the tables was what

government, local authorities and politicians could do to help business.

The other main speaker, was John Brandler, owner of Brandler Galleries, 1 Coptfold Road, Brentwood, who was the sponsor of the July Business Breakfast.

"As opposed to a shop, a gallery is here to inform the clients," he explained. "Art is there to enjoy. The best art collections have always been bought 'by eye', not by price. Be true to your eye."

John also talked about how he worked with various charities to supply works of art for events, where, for instance, they were the prizes in a silent auction. "One of our artists raised £100,000 on one night," he said.

# MP praises the job-creators at Business Breakfast

MP Alex Burghart hailed the delights of the borough and praised small businesses as being job-creators at the Chamber's July Business Breakfast.

In an entertaining and thoughtful speech he described his previous work for the government (involving education and welfare), saying:

"I loved working in No 10 – it was fascinating and I felt very privileged to have had the opportunity. But



you don't get the chance to be part of community and that's one of the things I'm greatly enjoying about my new job."

Alex then gave his views on the current challenges facing local and central government and the country's businesspeople. The Conservatives needed to maintain their record on jobs, the economy, and education and had to be able to build enough homes to meet demand, he said.

He noted that unemployment was at a 40-year low, and he praised the vital role played by small-to-medium businesses, saying: "It is people like you who create jobs."
